Contract

• We discuss the process, the amount required to meet your needs and will provide you with a contract for review and answer any further questions

Step 2

Approval Process

- As part of our approval process, we require your submission of two pieces of personal identification, a copy of the business name (title) registration
- We will also perform Law Society Review, PPSA and BIA searches, prior to funding

Funding and Process

- Once the executed contract is received you can contact any of the partners on our program to source an expert/service
- The partner completes the assessment service and sends the invoice to you and cc's us
- We email you for authorization to pay the face value on the invoice

Step 3

- You reimburse the loan amount to Rhino Legal upon the settlement of the claim. If the file is settled within 24 months, no interest is charged
- We keep extensive records on sign-off and approvals as well as the payments to the partners removing the administrative burden from you and your team
- Two months prior to the interest trigger date, an email reminder is sent to you, followed by a further email advising that in one month the interest free period expires
